#### **Sheraton Inn on the Plaza**

Currently there are accommodations at the Sheraton Hotel which will cost \$159 an evening. That cost will remain the same whether there are one, two, three, or four per room. The hotel is on the western corner of the Kansas City Plaza. It is near some great restaurants and some great stores. Transportation will be provided daily to Rockhurst. For those who are bringing a significant other, there are numerous restaurants and shops within a short walking distance. Reservations must be made by June 20, 2017 to secure the group rate. Townhouse Village Summer 2017 There will be approximately 15-20 townhouses available on campus during the summer workshop. The townhouses include two separate bedrooms with a bath that accompanies each bedroom. There are two separate beds in each bedroom. There is also a kitchen and living room area. The cost of the townhouse apartment each night will be \$100, and an additional single charge of \$21 for linen per person.

Option 1: one person per bedroom at \$50 each night with additional linen charges.

Option 2: two persons per bedroom at \$25 each night with additional linen charges.

Option 3: It would also be possible for one person in one bedroom and two persons in the other, with appropriate pricing.
